Earlier this year, AaSys told you about new domains on the horizon like .coffee and .diamonds, which were created by ICANN, the organization who manages the registration of Internet domains. If you remember, the American Bankers Association (ABA) also created the fTLD Registry Services LLC in order to apply for and operate the .BANK and .INSURANCE gTLDs on behalf of the global banking and insurance communities. This new company is owned, operated and managed by banks, insurance companies and other leaders in the financial industry around the world who understand the security challenges the financial sector faces. fTLD Registry Services LLC created a more protected, trusted and easilyidentifiable space on the Internet for financial companies and their customers.

The new domains for financial institutions, .bank and .creditunion, became available on June 1st and will be rolled out in phases. After June 24th, registration will be open for all eligible financial institutions around the world. Although it has only been a couple of weeks since these domain names have been introduced, experts have already evaluated what they see as the PROs and CONs of this new addition:

#### Pros

- Security. The new domain names can provide better security. Many of the security measures fTLD will require are high level.
- Cost. It is a more cost-effective alternative to establishing a personalized domain, as Citi and Bank of America have done.
- Branding Opportunities. Migrating your URL from .com to .bank could also present the opportunity to re-energize your brand.

#### Cons

- Time. A bank will have to create a good address and then go through the process to get it approved. That can take several days.
- Cost. Transitioning from .com to .bank requires all your current marketing documents to be changed. That will also include educating your customers about the new change as well, which can start to add up.
- Success rate is unknown. There have been other domain changes such as .biz that did not have the success rate many expected. However, experts say the .bank and .creditunion were very well thought out and planned, but if this was the right move may not be known for years.

Banks and credit unions will need to determine if the cost justifies the means and what risk, if any, will affect their customer base and their organization. Time will tell if this new change will set the standard in the banking industry or if many will just stick with what they know.

Recently while unveiling all the great perks of the new Windows 10, Microsoft introduced another great feature called Continuum for Phones. Continuum will allow Windows to switch its appearance to fit the screen and the device being used. Also, if Windows senses a keyboard or a mouse is connected, it will automatically switch to a desktop experience.
