Microsoft Support for Windows Server 2003 Has Officially Ended! Now What??

Over the past several months, AaSys has advised of the end support for Windows Server 2003 which occurred on July 14, 2015. Now that that has happened, now what? If you are still using the old operating system, you will no longer receive crucial security patches that help protect against viruses, spyware and malicious software.

In addition, Microsoft will no longer assist with the following:

- Assisted support
- Online content updates
- Software updates from Microsoft Update
- Security updates to help protect your PC from harmful viruses, spyware, and other malicious software, which can steal your personal information.

Users of Windows Server 2003 will have to say goodbye to patch Tuesdays and with that, they

may also encounter problems with software and hardware compatibility since new software applications and hardware devices may not be built for Windows Server 2003.

Computers using the old software will still work, however, the risk of viruses and other malicious attacks increases exponentially and could result in significant loss of data, business assets, and confidential documents.
